7. **References:** A good research article includes a comprehensive and up-to-date list of references that demonstrate the depth and breadth of the researcher's knowledge and understanding of the field of study.



Undang-Undang Republik Indonesia Nomor 28 Tahun 2014 tentang Hak Cipta
